Early identification of hearing impairment in children between 0-5 years of age Sub: and facility for free of cost cochlear implant.

Madam/Sir,

Government provides free cochlear implant facility to children below 5 years of age having family income of less than ₹15,000 per month. The implant is done in recognised hospitals in Odisha. The cochlear technology can help people with moderate and profound hearing loss in both ears and those who receive little benefit from hearing aids. It uses a surgically implanted prosthetic device inside the cochlea. The cochlear implant has an externally worn device which includes microphone, speech processor, transmitting coil, receiver stimulator package and the electrodes.

Considering that 4 out of 1000 children born suffer from hearing impairment, it is 2. important that this medical facility is popularised so that children in need can have their hearing ability restored.

Cochlear implant may be done by registration and submitting online application by 3. visiting the website ssepd.gov.in. The applicants should also upload the disability certificate (over 40%), family income certificate of less than ₹15,000 per month, residence proof, Aadhar number and two colour photographs along with the online application. After successful registration and submission of application forms, a suitable date will be fixed for the cochlear implant.

You are requested to give wide publicity to this service offered by the Government for 4. normalisation of hearing capability amongst the children of 0-5 years age group entirely free of cost.
